

**Cookie Policy** 

#### To: Users of the Company's website

**INSPIRE IVF COMPANY LIMITED** and its affiliates (the Company) ("hereinafter collectively referred to as the "Company") are committed to protecting your personal information and privacy. However, in order to provide you with quality services including a good experience using the Company's website or other Internet platforms of the Company (hereinafter collectively referred to as "Website"), the Company may collect, use and/or disclose personal information about your visit and use of the website (hereinafter collectively referred to as "personal information") through the use of cookies or other similar technologies.
