

Cookie Policy

To: Users of the Company's website

Thoresen & Company (Bangkok)Limited and its affiliates (the Company) (“hereinafter collectively referred to as the “Company”) are committed to protecting your personal information and privacy. However, in order to provide you with quality services including a good experience using the Company's website or other Internet platforms of the Company (hereinafter collectively referred to as “Website”), the Company may collect, use and/or disclose personal information about your visit and use of the website (hereinafter collectively referred to as “personal information”) through the use of cookies or other similar technologies. 1. What are cookies?

Cookies are small files that are saved on a computer or other Internet-connected device. For example, when you browse our website on your smartphone or tablet. When you visit the Company's website, cookies often save personal information such as your name, email address, user ID, IP address, and search terms, as well as user preferences (such as language). Cookies help us understand how you use our website so that we can improve your experience or better fulfill your needs by allowing us to track how you use it. Your

preferences will be remembered if you save cookies, making your next visit to the website more convenient, faster, and responsive to your needs.

2. What types of cookies does the Company use?

When you visit the Company's website, the following cookies may be used.

- A. Strictly Necessary Cookies
- B. Site Functionality Cookies
- C. Site Analytical/ Performance Cookies
- D. Marketing Cookies

3. How does the Company use cookies?

When you visit the Company's website, the Company will place some cookie files in your web browser to collect, use, and disclose your personal information, including your usage preferences. In this case, the Company uses cookies for the following purposes:

Category of cookies	Description	Lifetime
A. Strictly Necessary Cookies	This cookie type is essential to the functioning of the website. This allows you to access and use the information on our website safely.	90 days
B. Site Functionality Cookies	This cookie type enables you to browse the website and use our features such as registration and login. These cookies allow the website to recognize you when you return. It will enable us to tailor the content to your specific requirements. It also remembers your selections on the page, such as the language, location, and font size you select.	90 days
C. Site Analytical/ Performance Cookies	This cookie type assists us in recognizing and counting visitors to the website, as well as determining visitor behavior in	90 days

It can be shared and used by those companies to produce information about your preferences and to display relevant adverts on other websites.
